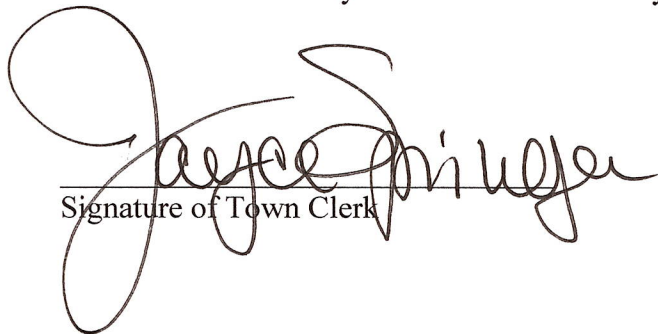
16. Approval of purchase orders as initialed.

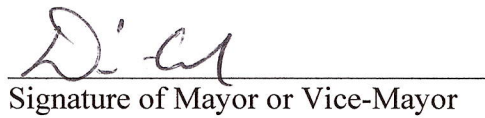
